The team discovered \$250,000 of corrections that were required prior to the close of escrow. The \$3M project was delivered with the use of design-build MEP under lease-leaseback agreement. Duties included project oversight, contract development and negotiations, design review, construction oversight, project closeout and owner move-in. Project was completed ahead of schedule and with a \$210,000 savings to the District.
